4. Background

The labeling requirements of prepackaged products and general requirements for the sale of goods subject to legal metrology control are stated in SANS 289 that is declared as compulsory by Government Notice 877 of 24 August 2018.

5. Concession

A concession is hereby granted in terms of Regulation 34 of the Legal Metrology Regulations, 2017 to sell the following products, of which the prescribed quantity deviates from the requirements of SANS 289, for a period until the South African National Standard, SANS 289, has been suitably revised and published:

Item 19(d)(2)	Dairy products – Powdered milk	Any quantity less than 10 g, then in integral multiples of 5 g from 10 g up to and including 100 g, then 125 g, 150 g, then in integral multiples of 50 g from 150 g up to and including 1 kg, 1,8 kg, 2 kg and any quantity above 2 kg
Item 30	Pasta products	Any quantity less than 10 g, then in integral multiples of 5 g from 10 g up to and including 100 g, then in integral multiples of 50 g from 150 g up to and including 1 kg, and integral multiples of 0,5 kg above 1 kg

6. Conditions of the concession
